D. AGENCY REPORTS

1. <u>Monthly Report</u> – (Info)

Mr. Greg Youell provided an update to the Board on MAPA activities for the month of September. He updated the federal Transportation Highway Bill which is stalled in the House and will not be moving forward in the short term. The Platteview Corridor public meeting was held on August 31, 2015. The meeting went well with a large turnout attending. Metro Transit turned in all of the environmental work to the FTA and the Categorical Exclusions (CE) was accepted by FTA for the Bus Rapid Transit project. There was a public meeting last month focusing primarily on station designs. Hoping to have the project completed by fall 2018, Metro and Omaha are also looking into the urban circulator and will begin a financial study on the project. MAPA staff members have attended several meetings for NROC. There was an NROC/EDA roundtable with representatives from IEDA, NDED, USDA and EDA. Staff also attended the Iowa EDA roundtable and will be attending the IARC / Iowa APA meeting in Sioux City. Also, staff attended a recent seminar in Kansas City with MARC, HUD and other federal agencies. All of the first round meetings for Heartland 2050 have been held for the various committees where participation has been very strong. More participation is wanted, though, from the private sector and the Hispanic and rural communities. Mr. Youell said he'll be attending a legislative hearing (LR155) on September 25, 2015. This Urban Affairs Committee will be with Sen. Sue Crawford and the meeting will be focused on economic development tools available in Nebraska.

2. <u>White paper on Economic Development Issues</u> – (Info)

Mr. Greg Youell explained to the Board the White Paper which describes and assesses the different economic tools available and provides comparisons with Iowa. This will be submitted to LR155 as it describes tools such as TIF, tax abatement, tax credits and incentives.

3. Joint Land Use Study (JLUS) Results - (Info)

Mr. Matt Roth updated the Board on the recently completed JLUS project. For two years a policy and technical advisory committee worked on a joint land use study with the professional help of Matrix, hired to help with this study for Offutt AFB. The study defines appropriate actions, is a collaborative document and is comprised of information to help with informed decisions. The goal of the study was to promote balance and compatible growth, sustainable environment, economic health and protect public health, safety and welfare while protecting the viability of current and future missions of Offutt AFB. The base contributes \$1.3 billion towards the local economy each year. Three workshops were held with a public comment period later held. Next steps are to develop MAPA's role in facilitating implementation with the cities and counties to identify strategies, short-term action and to evaluate and apply for grant assistance.

EPA Sets New Ozone Standard

The EPA announced that it will decrease the ozone standard from 65 to 70 parts per billion (ppb). This was the highest value in the proposed range of 65-70 ppb. The Omaha metro area's current design value (based on a 3-year average) is 67 ppb. The lower standard means that more metro areas risk going into "non-attainment," which can provide our region with an advantage for purposes of economic development.

Students from Dr. Blair's class in the UNO Master's in Public Administration (MPA) program are working on a program evaluation of MAPA's Little Steps Big Impact as part of their graduate course. They will conclude their research with a presentation on their findings and recommendations for improving the project.

House T&I Committee Passes Highway Reauthorization Bill out of Committee

On October 22nd, the House Transportation and Infrastructure Committee passed the Surface Transportation Reauthorization and Reform (STRR) Act (H.R. 3763) by voice vote following the markup. The House Bill takes a different approach from the Senate's DRIVE Act. It is a 3-year bill with an additional 3 years possible if certain funding requirements are met. It did not fix the reduction in STP funds for local governments, fixes the concern of transit representation on Boards and MPOs, and provides additional flexibility to fund non-NHS bridges.

Veteran's Grant for One Call Center

Significant progress is being made in MAPA's One Call Center project. Metro is now interested in being a partner in the project and helping to lead the development with local transit agencies. MAPA and Metro staff met recently with VA Director Don Burman who committed to supporting and partnering on the project.

Douglas County Transportation Projects

FHWA called a meeting earlier this month to bring everyone together to discuss plans for the 180th Street project. This is a \$30 million project which is programmed for FY-2019 to utilize multiple years of funding, and has been stuck in NEPA since 2006. Clear goals and deadlines were set and stakeholders felt it was a positive meeting.

Omaha, Douglas County and MAPA staff will meet next week to discuss 144th Street which will be cut off by growth of UNO's Allwine Prairie Preserve. MAPA coordinated a study in 2007 that proposed various concepts to ensure continuity of the transportation system.

MAPA Working With Partners on State Funding

MAPA continues to work on acquiring the State funding appropriated in the 2015 Legislature through NROC and Joe Kohout. The N-DED Director was removed and we continue to talk with DED staff members and Senators.

NARC's Analysis of the Surface Transportation Reauthorization and Reform Act

Updated 10/22/2015

The House Transportation and Infrastructure (T&I) Committee last week released its proposal to reauthorize the nation's surface transportation program, in advance of a scheduled committee markup on Thursday, October 22. The *Surface Transportation Reauthorization and Reform Act* (STRR) is a three-year bill with an additional three years possible if certain Congressional requirements for funding are met. In total, the bill would provide \$325 million in contract authority over the entire six-year life of the bill. What follows is a brief review of the legislative items NARC has been following most closely. A more detailed analysis will be forthcoming.

Surface Transportation Program (STP): STP has been the primary focus of NARC's legislative efforts regarding transportation reauthorization. Namely, increasing the suballocation levels to increase funding for local projects.

The House bill makes several major changes to STP, starting with changing the name to the "Surface Transportation Block Grant Program." This caused some immediate confusion as to what this change means, and the reality is that it likely means very little. STP functions as a block grant program anyway (the Congressional Budget Office <u>considers it</u> a block grant program), and there don't appear to be any major changes in the law that radically change how the program operates.

More importantly, the House bill Increases suballocation 1% each year up to 55% in the fifth and sixth years of the bill. In addition, the STRR Act does grow the STP base funding more quickly than other programs on a percentage basis, albeit at levels of growth that are still well below what is needed to meet needs. The increase in suballocation is clearly a victory for local authority, but the enthusiasm is tempered somewhat by the fact that this bill only has three years of guaranteed funding, and requires a "trigger" to ensure the last three years of the bill are enacted. Since the increase in suballocation is back loaded, the bill only guarantees an increase in suballocation to 53%.

The House bill also restructures the list of eligible STP projects. It does not remove any eligibilities, by virtue of a grandfather clause preserving all previous eligibilities. The bill does, however, add several new eligible project categories: safe routes to school; boulevards and other roadways largely in the right-of-way of former Interstate routes or other divided highways; workforce development, training, and education; projects that facilitate direct intermodal interchange, transfer, and access into and out of a port terminal; costs associated with providing Federal credit assistance (TIFIA); and public-private partnerships.



Transportation Alternatives Program (TAP): The House took an interesting approach to the TAP program, attempting to thread the needle between members who want to preserve the program and those who want to eliminate it. TAP essentially remains in the bill, but is now called an "STP Set-Aside." As with STP, all previously eligible TAP project categories have been preserved. The STP Set-Aside is funded annually with a flat \$819.9 million from the STP program; these funds are subtracted before the suballocation by population calculation is done, so this plus up does not by itself increase suballocated funding. The overall STP program is plussed-up so that the TAP program does not impact STP funding.

The calculation of the amount of TAP funding each state receives remains the same as in MAP-21, using 2009 transportation enhancement funding levels as the baseline. Distribution within each state remains largely the same as in MAP-21. The State can use 50% of the funds for projects anywhere in the state, while the other 50% is distributed based on population, and the funds are required to be distributed on a competitive basis. The House bill also provides flexibility for MPOs in areas over 200,000 to flex up to 50% of their TAP dollars annually for use on any eligible STP project.

Metropolitan Planning (PL) Funding: PL funding grows, but only at the minimal rate that most other programs grow (1.4% in the first year of the bill). This is well below the growth for PL in the Senate DRIVE Act and even further below levels NARC requested in the bill.

Transit Representation of the Boards of MPOs that Represent TMA's: In an effort to clarify Congressional intent regarding a provision in MAP-21 that requires transit to be represented on the boards of large MPOs, the House adopted identical Senate language that would ensure that large MPOs don't need to restructure or seek a change in state statute to comply with this requirement.

Bridges: In a major departure from the Senate's DRIVE Act, the House makes onsystem, non-NHS bridges eligible for funding under the National Highway Performance Program (NHPP). The Senate's approach, which would take 15% off the top of STP for an expanded bridge set-aside, fails to take into account that when the bridge program was eliminated in MAP-21, most of that funding went into NHPP. It's far more equitable that NHPP money be used to fill the so-called "doughnut hole" created by the elimination of the bridge program.



The Senate EPW DRIVE Act: Lots to Like, But Improvements Needed June 25, 2015

This week, the Senate Environment and Public Works (EPW) Committee passed out of committee – on a 20-0 vote – a transportation authorization proposal called the *Developing a Reliable and Innovative Vision for the Economy (DRIVE) Act* (S. 1647). The DRIVE Act is a six-year bill with \$278 billion in contract authority for fiscal years 2016 to 2021. This is an increase of more than \$16 billion over baseline (current) funding as estimated by Congressional Budget Office, and would require the Senate Finance Committee to find some \$80 billion to fund just this portion of the surface transportation program. Keep in mind that EPW only covers highways. The Banking Committee is responsible for the transit title, which will further drive up the amount that Finance will be required to find to fund a comprehensive package.

Elements of the bill most important to NARC members:

• **TAP is 100% Suballocated**. One of NARC's primary requests for MAP-21 reauthorization is an increase in suballocation. The EPW bill makes major changes to the transportation alternatives program (TAP), including suballocating 100% of the program by population. This is essentially a doubling of TAP funding. The bill also curtails states' ability to transfer TAP funds to other programs, as in current law.

EPW funds TAP at a flat \$850 million per year for the life of the bill, instead of funding it as a 2% set-aside of all the Federal Highway Administration (FHWA) funding, as under current law. This represents significant growth from the \$819 million TAP will receive this year, but changing the way the program is funded eliminates what would have been significant funding increases in the out years of the bill (TAP would be funded at \$981 million in the final year of the DRIVE Act under the current formula).

• STP Suballocation is Increased (in percentage terms, at least). EPW increased suballocation of the Surface Transportation Program (STP), but the story here is a lot more complicated than with TAP. Though 55% of STP is now suballocated by population and the program sees modest funding growth over the course of the bill, the first few years of the EPW bill would actually decrease overall levels of suballocated STP funding.

How could this be? The reason lies in the treatment of the bridge set-aside. What is now known as the off-system bridge set-aside would be expanded to also allow funding of on-system, non-NHS bridges. Under the DRIVE Act, the funding for the bridge set-aside would come "off the top" of the total STP funding amount (whereas now it comes out of the "anywhere in the state" portion of the program). As a result, what is suballocated under STP is 55% of the 85% of the program that remains after the bridge set-aside. That is just shy of 47%, and a decrease from the 50% of the program that is suballocated by population under current law.

As a result, under the DRIVE Act, the amount of dollars suballocated by population would not increase relative to current spending until FY 2019. And to put it another way, locals would be better off with six years of STP at this year's funding level and 50% suballocation than the higher funding levels in the EPW bill at a lower percentage.

One additional change to STP is in the "apportionment" formula, which determines how much each core program in a state receives of its total funding in a given year. The DRIVE Act would decrease slightly (from 29.3% to 29.0%) the share of funds that go to STP and by a more significant amount (from 7% to 6%) the share that goes to the Highway Safety Improvement Program. As a result, the share that goes to the National Highway Performance Program increases from 53.7% to 55%. These changes, especially in a no-growth or slow-growth funding environment, are another move in the wrong direction within the STP program.

- Clarifies Transit Representation on MPO Boards. A provision in MAP-21 requires an MPO that serves a transportation management area (TMA) to include a transit representative on its policy (i.e. voting) board. This provision was problematic for a number of reasons, and the EPW Committee listened to NARC's concerns. The DRIVE Act would not remove the requirement entirely, but does prevent MPOs from having to change their bylaws or enabling statutes to meet the transit representation requirements, and allows a local elected official to serve as the transit representative when appropriate. These are welcome changes.
- New Programs, Large and Small. The EPW bill would create a number of new programs:
 - A Freight Program, funded at \$13.4 billion over six years. This builds upon MAP-21's freight program, but provides dedicated funding and makes some key modifications, like including multimodal freight connectors and adding a "critical urban freight corridors" category.
 - Assistance for Major Project program, funded at \$2.4 billion over six years. This is a discretionary program to help fund major highway projects (\$350 million or more) with grants of at least \$50 million.
 - The Technology and Innovation Deployment Program requires that 50% of the funds for this program be used on grants, including to MPOs and local governments, for demonstration projects that will accelerate deployment and eventual adoption of transportation research activities. It is important to note that MPOs and local governments were added as eligible recipients thanks to an amendment offered by Senators Booker (D-NJ) and Wicker (R-MS) that was accepted at the markup.
 - The System Operations and ITS Deployment Grant Program will provide \$30 million each year for grants (including grants for MPOs) that accelerate deployment, operation, management, intermodal integration, and interoperability of ITS and ITS-enabled strategies. Uses include: deployment of autonomous, vehicle-to-vehicle, and vehicle-to-infrastructure communications technologies; establishment and implementation of ITS and ITS-enable strategies; creation of networks that link metropolitan and rural surface transportation systems into an integrated data network; support for establishment and institutional relationships; and carrying out multi-modal and cross-jurisdictional planning.

Though the EPW bill is far from a perfect bill, it does have a number of wins that NARC sought and overall does provide more suballocation than under existing law (because of the increased suballocation of TAP). On the whole, this is a bill to build upon in the House, where our prospects for increases in suballocation are real. This is the first step on a long journey to reauthorization – and there will be additional opportunities for local officials and MPOs to weigh in and influence the outcome of the legislation – to ensure that local governments have the resources they need to improve and maintain the nation's transportation system.

Executive Director's Report

EPA Sets New Ozone Standard

The EPA announced that it will decrease the ozone standard from 65 to 70 parts per billion (ppb). This was the highest value in the proposed range of 65-70 ppb. The Omaha metro area's current design value (based on a 3-year average) is 67 ppb. The lower standard means that more metro areas risk going into "non-attainment," which can provide our region with an advantage for purposes of economic development.

Students from Dr. Blair's class in the UNO Master's in Public Administration (MPA) program are working on a program evaluation of MAPA's Little Steps Big Impact as part of their graduate course. They will conclude their research with a presentation on their findings and recommendations for improving the project.

House T&I Committee Passes Highway Reauthorization Bill out of Committee

On October 22nd, the House Transportation and Infrastructure Committee passed the Surface Transportation Reauthorization and Reform (STRR) Act (H.R. 3763) by voice vote following the markup. The House Bill takes a different approach from the Senate's DRIVE Act. It is a 3-year bill with an additional 3 years possible if certain funding requirements are met. It did not fix the reduction in STP funds for local governments, fixes the concern of transit representation on Boards and MPOs, and provides additional flexibility to fund non-NHS bridges.

Veteran's Grant for One Call Center

Significant progress is being made in MAPA's One Call Center project. Metro is now interested in being a partner in the project and helping to lead the development with local transit agencies. MAPA and Metro staff met recently with VA Director Don Burman who committed to supporting and partnering on the project.

Douglas County Transportation Projects

FHWA called a meeting earlier this month to bring everyone together to discuss plans for the 180th Street project. This is a \$30 million project which is programmed for FY-2019 to utilize multiple years of funding, and has been stuck in NEPA since 2006. Clear goals and deadlines were set and stakeholders felt it was a positive meeting.

Omaha, Douglas County and MAPA staff will meet next week to discuss 144th Street which will be cut off by growth of UNO's Allwine Prairie Preserve. MAPA coordinated a study in 2007 that proposed various concepts to ensure continuity of the transportation system.

MAPA Working With Partners on State Funding

MAPA continues to work on acquiring the State funding appropriated in the 2015 Legislature through NROC and Joe Kohout. The N-DED Director was removed and we continue to talk with DED staff members and Senators.

NARC's Analysis of the Surface Transportation Reauthorization and Reform Act

Updated 10/22/2015

The House Transportation and Infrastructure (T&I) Committee last week released its proposal to reauthorize the nation's surface transportation program, in advance of a scheduled committee markup on Thursday, October 22. The *Surface Transportation Reauthorization and Reform Act* (STRR) is a three-year bill with an additional three years possible if certain Congressional requirements for funding are met. In total, the bill would provide \$325 million in contract authority over the entire six-year life of the bill. What follows is a brief review of the legislative items NARC has been following most closely. A more detailed analysis will be forthcoming.

Surface Transportation Program (STP): STP has been the primary focus of NARC's legislative efforts regarding transportation reauthorization. Namely, increasing the suballocation levels to increase funding for local projects.

The House bill makes several major changes to STP, starting with changing the name to the "Surface Transportation Block Grant Program." This caused some immediate confusion as to what this change means, and the reality is that it likely means very little. STP functions as a block grant program anyway (the Congressional Budget Office <u>considers it</u> a block grant program), and there don't appear to be any major changes in the law that radically change how the program operates.

More importantly, the House bill Increases suballocation 1% each year up to 55% in the fifth and sixth years of the bill. In addition, the STRR Act does grow the STP base funding more quickly than other programs on a percentage basis, albeit at levels of growth that are still well below what is needed to meet needs. The increase in suballocation is clearly a victory for local authority, but the enthusiasm is tempered somewhat by the fact that this bill only has three years of guaranteed funding, and requires a "trigger" to ensure the last three years of the bill are enacted. Since the increase in suballocation is back loaded, the bill only guarantees an increase in suballocation to 53%.

The House bill also restructures the list of eligible STP projects. It does not remove any eligibilities, by virtue of a grandfather clause preserving all previous eligibilities. The bill does, however, add several new eligible project categories: safe routes to school; boulevards and other roadways largely in the right-of-way of former Interstate routes or other divided highways; workforce development, training, and education; projects that facilitate direct intermodal interchange, transfer, and access into and out of a port terminal; costs associated with providing Federal credit assistance (TIFIA); and public-private partnerships.



Transportation Alternatives Program (TAP): The House took an interesting approach to the TAP program, attempting to thread the needle between members who want to preserve the program and those who want to eliminate it. TAP essentially remains in the bill, but is now called an "STP Set-Aside." As with STP, all previously eligible TAP project categories have been preserved. The STP Set-Aside is funded annually with a flat \$819.9 million from the STP program; these funds are subtracted before the suballocation by population calculation is done, so this plus up does not by itself increase suballocated funding. The overall STP program is plussed-up so that the TAP program does not impact STP funding.

The calculation of the amount of TAP funding each state receives remains the same as in MAP-21, using 2009 transportation enhancement funding levels as the baseline. Distribution within each state remains largely the same as in MAP-21. The State can use 50% of the funds for projects anywhere in the state, while the other 50% is distributed based on population, and the funds are required to be distributed on a competitive basis. The House bill also provides flexibility for MPOs in areas over 200,000 to flex up to 50% of their TAP dollars annually for use on any eligible STP project.

Metropolitan Planning (PL) Funding: PL funding grows, but only at the minimal rate that most other programs grow (1.4% in the first year of the bill). This is well below the growth for PL in the Senate DRIVE Act and even further below levels NARC requested in the bill.

Transit Representation of the Boards of MPOs that Represent TMA's: In an effort to clarify Congressional intent regarding a provision in MAP-21 that requires transit to be represented on the boards of large MPOs, the House adopted identical Senate language that would ensure that large MPOs don't need to restructure or seek a change in state statute to comply with this requirement.

Bridges: In a major departure from the Senate's DRIVE Act, the House makes onsystem, non-NHS bridges eligible for funding under the National Highway Performance Program (NHPP). The Senate's approach, which would take 15% off the top of STP for an expanded bridge set-aside, fails to take into account that when the bridge program was eliminated in MAP-21, most of that funding went into NHPP. It's far more equitable that NHPP money be used to fill the so-called "doughnut hole" created by the elimination of the bridge program.



The Senate EPW DRIVE Act: Lots to Like, But Improvements Needed June 25, 2015

This week, the Senate Environment and Public Works (EPW) Committee passed out of committee – on a 20-0 vote – a transportation authorization proposal called the *Developing a Reliable and Innovative Vision for the Economy (DRIVE) Act* (S. 1647). The DRIVE Act is a six-year bill with \$278 billion in contract authority for fiscal years 2016 to 2021. This is an increase of more than \$16 billion over baseline (current) funding as estimated by Congressional Budget Office, and would require the Senate Finance Committee to find some \$80 billion to fund just this portion of the surface transportation program. Keep in mind that EPW only covers highways. The Banking Committee is responsible for the transit title, which will further drive up the amount that Finance will be required to find to fund a comprehensive package.

Elements of the bill most important to NARC members:

• **TAP is 100% Suballocated**. One of NARC's primary requests for MAP-21 reauthorization is an increase in suballocation. The EPW bill makes major changes to the transportation alternatives program (TAP), including suballocating 100% of the program by population. This is essentially a doubling of TAP funding. The bill also curtails states' ability to transfer TAP funds to other programs, as in current law.

EPW funds TAP at a flat \$850 million per year for the life of the bill, instead of funding it as a 2% set-aside of all the Federal Highway Administration (FHWA) funding, as under current law. This represents significant growth from the \$819 million TAP will receive this year, but changing the way the program is funded eliminates what would have been significant funding increases in the out years of the bill (TAP would be funded at \$981 million in the final year of the DRIVE Act under the current formula).

• STP Suballocation is Increased (in percentage terms, at least). EPW increased suballocation of the Surface Transportation Program (STP), but the story here is a lot more complicated than with TAP. Though 55% of STP is now suballocated by population and the program sees modest funding growth over the course of the bill, the first few years of the EPW bill would actually decrease overall levels of suballocated STP funding.

How could this be? The reason lies in the treatment of the bridge set-aside. What is now known as the off-system bridge set-aside would be expanded to also allow funding of on-system, non-NHS bridges. Under the DRIVE Act, the funding for the bridge set-aside would come "off the top" of the total STP funding amount (whereas now it comes out of the "anywhere in the state" portion of the program). As a result, what is suballocated under STP is 55% of the 85% of the program that remains after the bridge set-aside. That is just shy of 47%, and a decrease from the 50% of the program that is suballocated by population under current law.

As a result, under the DRIVE Act, the amount of dollars suballocated by population would not increase relative to current spending until FY 2019. And to put it another way, locals would be better off with six years of STP at this year's funding level and 50% suballocation than the higher funding levels in the EPW bill at a lower percentage.

One additional change to STP is in the "apportionment" formula, which determines how much each core program in a state receives of its total funding in a given year. The DRIVE Act would decrease slightly (from 29.3% to 29.0%) the share of funds that go to STP and by a more significant amount (from 7% to 6%) the share that goes to the Highway Safety Improvement Program. As a result, the share that goes to the National Highway Performance Program increases from 53.7% to 55%. These changes, especially in a no-growth or slow-growth funding environment, are another move in the wrong direction within the STP program.

THIS SUPPLEMENT AGREEMENT is between the Omaha-Council Bluffs Metro Area Planning Agency ("MAPA"), and the State of Nebraska, Department of Roads ("State"), collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, MAPA and the State entered into an agreement ("Original Agreement") providing for financial participation for Phase 1 activities and the roles and responsibilities of the Parties, and

WHEREAS, the Parties wish to provide for the financial participation for Phase 2 activities by this Supplemental Agreement.

NOW, THEREFORE, in consideration of these facts and mutual promises, the Parties agree as follows:

SECTION 1. PHASE 2 ACTIVITIES

Phase 2 will include, but not be limited to, the following activities:

- Project Management and QA/QC
- Coordination with Other Studies and Projects
- Project Meetings
- Update MAPA Model Based on AirSage and INRIX Data
- Refine Assessment of Existing and Potential Funding Strategies
- System Preservation/ Asset Management Life-cycle Strategies Assessment
- Develop Potential Strategies by Issue Corridors/Areas
- Evaluate Feasibility and Viability of Corridor/Area Strategies
- Special Sub-Area Study Sarpy County I-80 Interchange Assessment
- Packaging of Corridor/Area Strategies into 2040 Regional Strategy Packages
- Evaluation and Testing of 2040 Regional Strategy Packages
- Select Recommended 2040 Regional Strategy Package
- Develop Draft 2050 LRTP
- Develop Focused Freeway Corridor Alternatives
- Evaluation and Testing of Focused Freeway Corridor Alternatives
- Select Recommended Freeway Corridor Alternatives for Further Refinement in Phase 3
- Phase 2 Documentation

SECTION 2. FINANCIAL RESPONSIBLITIES

The estimated cost for Phase 2 activities is approximately \$1,600,000. NDOR and MAPA will share the costs of the study as follows:

- NDOR will provide the required Obligation Authority (OA) estimated at \$1,280,000.
- NDOR will provide the match using state funds estimated at \$320,000.
- MAPA will provide the required apportionments using MAPA-Omaha Surface Transportation Program (STP).
- MAPA will include this phase in the MAPA's FY-2016 Transportation Improvement Program (TIP).
- The State will not invoice MAPA for any accrued cost.

The estimated cost for Phase 3 activities is approximately \$1,500,000. The cost for Phase 3 will depend on the results from the Phase 2 portion of the study. Consequently, upon completion of Phase 2, the Parties will enter into a supplemental agreement to detail the financial responsibilities of the Parties.

SECTION 3. ENTIRE AGREEMENT

The Original Agreement, any and all other previous supplements thereto, and this Supplemental Agreement, constitute the entire agreement ("The Agreement") between the Parties. The Agreement supersedes any and all other previous communications, representations, or other understandings, either oral or written; all terms and conditions of the Original Agreement and all previous supplements thereto, to the extent not superseded, remain in full force and effect, and are incorporated herein as if set forth in their entirety.

WHEREAS, the above-named nine (9) Original Members have previously entered into an INTERLOCAL COOPERATION AGREEMENT BETWEEN THE POLITICAL SUBDIVISION OF THE STATE OF NEBRASKA, FOR THE ADVANCEMENT OF COMPRESSED NATURAL GAS AND ELECTRIC VEHICLE INFRASTRUCTURE AND COMPRESSED NATURAL GAS AND ELECTRIC VEHICLE USE to form the Nebraska Community Energy Alliance ("NCEA") in connection with each respective Original Member's "commitment to participate" submitted to the Nebraska Environmental Trust ("NET") concerning the NET-sponsored project, Connecting Nebraska Communities Driving America's Fuel! to-time be amended, for the purpose of identifying, applying for, administering or otherwise making available to its members such grants or funding sources as are proper under this Agreement;

NOW, THEREFORE, in consideration of the foregoing and the terms and conditions set forth below, the members of NCEA being parties hereto agree as follows:

1. <u>**Creation**</u>. The NCEA members hereby create a joint entity to be known as the "Nebraska Community Energy Alliance" hereinafter referred to as "NCEA" which shall constitute a separate body politic. The NCEA shall function as a local subdivision of government which shall be empowered to make all financial and policy decisions affecting the purpose for which it is created.

2. **Purpose**. The NCEA is organized by and for Nebraska's communities to promote transportation and housing choices that include lifecycle cost of ownership, retained energy value, and economic competitiveness by coordinating and leveraging federal and state policies and investments to community projects demonstrating direct high impact.

3. <u>Board of Directors</u>. The affairs, actions, and conduct of the business of the NCEA shall be by a Board of Directors ("Board"). The Board shall exercise authority over NCEA in accordance with applicable laws and shall set the policy delegating to its officers, agents, and committees as appropriate.

Membership Board Composition. The Membership Board shall consist of one representative from each NCEA member which representative shall be appointed by resolution of the governing body of such member. Each NCEA member may at its discretion appoint one alternative representative who will represent that NCEA member in the event the representative is unable to attend a meeting of the Board. The representative and alternate shall serve at the pleasure of his or her respective organization. Any vacancy which occurs in the Board shall be filled within thirty days through the appointment of a replacement by the respective NCEA member.

a. **Eligibility**. In addition to any other eligibility requirements, a Board candidate must be a NCEA member representative. No NCEA member may be represented by more than one (1) representative on the Board.

b. **Vacancies.** If a member of the Board of Directors at any time during his or her term of office no longer meets the requirements for the initial appointment of the member, or resigns or no longer is able to serve as a member of the Board of Directors, the office of such Board member shall be deemed to be vacant as of the date such Board member no longer meets such requirements or resigns or is no longer able to serve as a member of the Board. A vacancy on the Board shall be filled by appointment of a new representative by resolution of the applicable governing body represented by the vacant Board member.

c. Meetings and Conduct of Business. Meetings of the Board shall be conducted at least annually and at such other frequent times as may be required by the business of NCEA or governing law. A majority of Board members shall constitute a quorum for the transaction of business provided that the Board shall have no authority to approve any item before the Board, except by an affirmative vote from a majority of its members, unless otherwise specifically required by law. Meetings shall be conducted in accordance with the Nebraska Open Meetings Act, NEB. REV. STAT. §§ 84-1407 (Reissue 2014), *et. seq.* as the same may from time-to-time be amended. Robert's Rules of Order, latest edition, shall govern all meetings of the Board of Directors.

d. Teleconferencing shall be allowed provided that NCEA follows state restrictions on its use.

e. **Officers of the Board.** The Board shall select a chairman, vice-chairman, secretary, and treasurer.

- i. Chairman. The Chairman shall preside at all meetings of the Board and have such general powers and duties of supervision and management as shall be necessary and germane or required for the execution and prosecution of the affairs of NCEA.
- **ii.** Vice-Chairman. The Vice-Chairman shall serve in the absence of the Chairman and, in the Chairman's absence, shall have all of the powers and duties of the Chairman and shall have such other powers and duties as the Chairman or members shall from time-to-time delegate to the Vice-Chairman.
- **iii.** Secretary. The Secretary shall keep minutes of all meetings conducted by NCEA and shall be the keeper of the records of NCEA.
- **iv.** Treasurer. The Treasurer shall prepare and submit in writing a quarterly report of the state of finances of NCEA and pay NCEA money only upon authorization granted by the Board or Chairman. Payment of all accounts under authorization shall be made on check signed by the Treasurer.

In addition to the foregoing, the officers shall have such other and additional duties, powers, privileges, and authority as the Board may, in its bylaws or otherwise, determine appropriate or necessary.

f. **Executive Board Composition.** The Executive Board shall consist of the four Membership Board Officers and two At Large members elected by the Membership Board.

Executive Board elections will be held annually at NCEA's Annual Membership Meeting. NCEA Executive Board will meet at a minimum quarterly to monitor organizational operations and conduct routine business.

4. Projects.

NET-CNCDAF Project 14/149. With respect to the NET-CNCDAF а. Project 14/149, the members participating in such Project agree to cooperate with each other and other public agencies on electric vehicle infrastructure and compressed natural gas and electric vehicle use project activities at the earliest practical time to avoid delays and duplication of effort later, head off potential conflicts, and ensure that planning and project development decisions reflect environmental values. Participating members agree to coordinate to reduce duplication between requirements under the National Environmental Policy Act of 1969 (42 U.S.C. 4321 et seq.) and state and local planning and environmental review requirements, unless the agencies are specifically barred from doing so by applicable Members participating in the NET-CNCDAF Project 14/149 also agree to provide a law. minimum of a 50/50 match as may be required by grants or up to \$15,000 per vehicle and \$3,600 per electric vehicle infrastructure. Said members further agree to provide appropriate insurance coverage for all equipment and vehicles purchased or leased pursuant to the NET-CNCDAF Project 14/149. Participating members also agree to provide information identifying potential impacts and mitigation issues in a combined method.

b. **Other Projects and Granting Agencies**. As determined by the NCEA Board, NCEA may develop and administer other projects and seek funding for the same. "Other projects" shall be broadly construed but must be consistent with NCEA's purpose, this Agreement, and applicable laws and regulations. "Granting agency" as used in this Agreement, shall also be broadly construed as any entity, individual, or agency providing funding which is developed or administered by NCEA. No project may be developed or administered, nor agreement with any granting agency be entered into, by NCEA unless first being approved by the NCEA Board of Directors.

5. Additional Members.

a. **Method.** The Board may invite other public agencies to join the NCEA, and such invitees shall become a New Member by executing a New Member Counterpart of this Agreement and making the initial contribution as described in Paragraph 7.a of this Agreement.

b. **Participation Rights.** A New Member shall not be guaranteed opportunity to participate in grants or other projects in which NCEA is already involved on the date the New Member joins NCEA. A New Member is entitled to consideration by NCEA for participation in any grants or projects in which NCEA becomes involved after the date on which the member joins NCEA.

6. **Powers and Responsibilities**. The powers and responsibilities of NCEA as carried out by the Board shall include, but not be limited to the following:

- a. Set budgets and to provide for a system of budgeting, accounting, auditing, and reporting of all NCEA funds and transactions for a depository and for the bonding of employees and officials;
- b. Establish the fiscal year of the NCEA and establish fiscal policies;
- c. Establish reasonable rules and regulations for the participation in NCEA and participate in any project or funding opportunity obtained or administered by NCEA;
- d. Seek and obtain contracts, agreements and other arrangements whereby NCEA or its members will receive support and assistance for the purpose of pursuing the objects and purposes of NCEA from such other entities as NCEA from time to time shall determine necessary or appropriate, including, but not limited to, for-profit and non-profit organizations, and all other persons, provided, however, such contract shall not exceed any authority or powers delegated to NCEA by its members;
- e. Provide for the identification, obtaining, maintenance, management, reporting, and administration of projects for grant and funding opportunities to further the best interests of the political subdivisions which are parties hereto and the citizens of such political subdivisions consistent with the purpose of NCEA;
- f. Contract for the delegation or performance of duties imposed upon it herein including, but not limited to, the budgeting, accounting, auditing, and reporting and such other professional services including, but not limited to, legal services, financial services, and accounting services. Such contract may be with an outside party or other appropriate vendors. Such contract may be entered into with and between nonparties to this Agreement or with NCEA members;
- g. Manage and review operations;
- h. Address any related questions and concerns of the general public;
- i. Make application for any permits or licenses required by regulating agencies;
- j. Hire and fire such personnel as are needed to carry out the objectives of NCEA, fix their compensation benefits, enact personnel rules and regulations, and enter into employment agreements;

- k. Adopt bylaws and standard operating procedures regarding the organization and operation of the NCEA and amend and repeal bylaws, rules, regulations, or standard operations to carry out and effectuate its powers and purposes;
- I. Make application for and receive grants related to the purposes for which NCEA was formed;
- m. Borrow funds as necessary;
- n. Contract with and compensate consultants for professional services including, but not limited to, lawyers, accountants, and others necessary or useful and convenient to the purposes of NCEA;
- o. Sue and be sued;
- p. Acquire, hold, use and dispense appropriately of funds received;
- q. Acquire, hold, use and dispose of real and personal property for the purposes of the NCEA;
- r. Make or cause to be made any action necessary or useful and convenient to carrying out the functions of the NCEA;
- s. Have a seal and alter the same at pleasure or dispose with the necessity thereof;
- t. Make application for, receive, and accept donations, gifts, grants, the guest appropriations, or other contributions or assistance and monies, services, materials, or otherwise from the United States or any of its agencies from the State or any of its agencies or political subdivisions or from any persons and to use or expend all such contributions in carrying out its operations not inconsistent with the requirements thereof;
- u. Establish advisory groups and/or committees by appointing individuals to carry out the purposes of NCEA and pay necessary and proper expenses of such group as the Board shall determine and dissolve such groups;
- v. Select a financial agent and invest funds or property as allowed under law and in accordance with requirements imposed by any granting agency;
- Purchase insurance, bond any employee or agent, for the purpose of protecting NCEA and its members against liability related to the operation or functions of NCEA;

- x. Employ such persons as are necessary to carry out the purposes of NCEA and pay the necessary and proper expenses of said persons; and
- y. Make and execute contracts, leases, and other instruments necessary or convenient to the exercise of its powers.
- z. All other powers authorized by the Interlocal Cooperation Act, Neb. Rev. Stat. § 13-801 et seq.

7. Finances and Budget.

a. **Funding**. Annually or at such other frequent intervals as the Board may determine, each of the NCEA members shall contribute such funds as are necessary to conduct the operations of NCEA. Each NCEA member shall make an initial contribution of One Thousand Dollars (\$1,000.00). This initial contribution shall be deposited in an account in the name of NCEA at a bank insured by the FDIC and selected by the Board.

b. **Assessment**. NCEA shall be funded by the revenues derived from granting agencies and/or other sources identified by the Board, provided, however, that in the event that funds derived from granting agencies and other sources identified by the Board are insufficient to service debt of NCEA, then in and in that event, the members of NCEA shall be assessed on proportional basis based on total funding received by the member during the preceding 24 month period as compared to total funding received by all NCEA members during the same preceding 24 month period, as determined as of the date of assessment. Each NCEA member shall have 60 days after receipt of notice from NCEA that an assessment is due to contribute its share of the funds required under the terms of the assessment.

c. **Budget.** In addition to any budget, reporting, or other financial requirements of any particular project or imposed by a granting agency, the NCEA Board shall, annually, beginning no more than 30 days after the formation of the NCEA and commencement of business, and continuing each year thereafter during the existence of the NCEA, establish and adopt a budget for the administration and management of the projects undertaken by the NCEA in fulfillment of its purpose. Upon completion of the budget, the Board shall determine the assessment to be submitted by each NCEA member and shall thereafter assess each NCEA member for said amount if any said amount has been determined as an assessment.

8. <u>**Conflicts of Interest</u>**. The members of NCEA agree to act in good faith in fulfilling the purpose of NCEA. It is expressly acknowledged and agreed that the NCEA is a public body and no profit or dividend will inure to the benefit of any individual. No Board member, public official, contractor or agent representing NCEA shall transact any business in his or her official NCEA capacity with any entity in which he or she, or any member of his or her immediate family, has a personal interest, without prior approval of the NCEA Board.</u>

9. <u>Limitation of Liability</u>.

a. **Indemnification.** Each NCEA member shall indemnify and hold harmless NCEA against any and all losses, claims, liabilities, suits or judgments, costs and expenses suffered by NCEA as a result of the member's breach of any obligation undertaken by such member or representation made by such member. NCEA shall likewise indemnify and hold harmless each NCEA member against any and all losses, claims, liabilities, suits or judgments, costs and expenses suffered by such member as a result of NCEA's breach of any obligation undertaken by NCEA.

b. **Right to Inspect.** Each NCEA member shall have the right to inspect the books or records maintained by NCEA upon demand made to NCEA and costs of such inspection shall be the responsibility of the inspecting member.

c. **Participation.** No NCEA member shall be liable for any expenses or costs with respect to any project in which the member is not a participant or a recipient of funding or other benefit.

- 10. Adherence to Applicable Requirements. The NCEA members agree to:
 - a. Pass appropriate ordinances or resolutions requiring compliance with any reporting or other requirements imposed by applicable law, NCEA or a granting agency; and
 - b. Submit such forms, financial reporting, or other information as is required by applicable law, NCEA or a granting agency.

11. <u>Withdrawal of Member</u>. In the event any member of NCEA desires to withdraw from this Agreement, said member shall forfeit any future opportunities for funding administered by NCEA, but shall remain liable for fulfilment of any obligation undertaken by the withdrawing member with respect to any granting agency, or the NCEA, and shall remain responsible for any unpaid assessments assigned to the member by the NCEA and any financial assurances that may have been provided by the member to the NCEA or a granting agency. Any member seeking to withdraw from membership in NCEA shall file in the office of NCEA a certified copy of the resolution of the member's governing body approving withdrawal and the withdrawal shall be effective upon such filing.

12. <u>Termination of Agreement.</u>

a. **Duration**. NCEA shall continue in existence and operation for the active life of the NET-CNCDAF Project 14/149, including all phases of the NET-CNCDAF Project 14/149, and thereafter as determined by the Board to be beneficial to the constituents of the members hereto, unless terminated as herein provided, but this Agreement shall terminate on or before the date which is sixty (60) years after execution of this Agreement by the first member unless extended in writing and approved by the Board.

b. **Dissolution.** NCEA may be dissolved by the governing bodies by a majority of the NCEA members adopting resolutions approving such dissolution, provided that NCEA may not be dissolved until all funding obligations, including but not limited to any reporting or other obligations to a granting agency, outstanding notes, agreements, or contractual obligations and legal claims shall have been satisfied in full. Upon dissolution of NCEA, each member shall become the owner of a fractional undivided interest in all remaining assets of NCEA. Each member's undivided fractional interest in such assets shall be determined in accordance with the total membership of NCEA at time of dissolution.

13. <u>Miscellaneous</u>.

- a. **Amendment and Modification**. This Agreement may be amended or modified only upon approval of a majority of the NCEA Membership Board.
- b. **Assignment.** No member may assign its rights under this Agreement.
- c. **Counterparts.** Original counterparts of this Agreement shall be executed and delivered by each Original and New member to the NCEA. Executed originals shall be placed on file at an office designated by the Board. The NCEA members agree that the separately executed copies of this Agreement constitute the NEBRASKA COMMUNITY ENERGY ALLIANCE INTERLOCAL COOPERATION AGREEMENT of the NCEA and shall be given full force and effect.
- d. Effective Date. This Agreement shall become effective upon the signing of all governing bodies of the respective original nine (9) named members hereto after each such member has adopted resolution approving and authorizing the execution of this Agreement. The NCEA established hereby shall come into existence upon the first meeting of the NCEA at a duly called public meeting. Each NCEA member shall provide to the NCEA a certified copy of each resolution approving and authorizing the execution of this Agreement and designating a Voting Delegate for the purpose of the annual membership meeting.
- e. **Governing Law.** This Agreement and all disputes related to or arising therefrom shall be governed, construed, and enforced in accordance with the laws of the

State of Nebraska, without regard to conflict of law rules, and exclusive jurisdiction of any dispute shall rest with the courts of the State of Nebraska.

- f. **Integration**. This Agreement contains the entire agreement of the parties. No representations were made or relied upon by any party other than those expressly set forth herein. All prior and contemporaneous negotiations, discussions, memos and other writing are merged and incorporated herein, it being the intention of the parties that this be a final and full expression of the their agreement. No agent, employee or other representative of any party hereto is empowered to alter any of the terms herein unless such alteration is done in writing and signed by all parties hereto.
- g. **Severability**. If any provision, term, or clause in this Agreement is held unenforceable, then the remaining provisions of this Agreement shall remain in full force and effect.
- h. **Headings**. The headings used in this Agreement are for convenience only and shall not be used to construe the terms of this Agreement.

INTERLOCAL COOPERATION AGREEMENT FOR COMPREHENSIVE

PLANNING SERVICE FOR THE SARPY COUNTY TRANSIT FEASIBILITY STUDY

This Agreement is by and between the County of Sarpy, Nebraska, hereinafter "County," and the Omaha—Council Bluffs Metropolitan Area Planning Agency, hereinafter "MAPA".

WHEREAS, the parties hereto are political subdivisions, duly authorized and existing under the laws of the State of Nebraska; and,

WHEREAS, the Parties wish to engage a consultant with expertise in transit planning to conduct a needs assessment and a feasibility study of transit services in Sarpy County, and

WHEREAS, pursuant to the Interlocal Cooperation Act, Neb. Rev. Stat.§ 13-801, et seq. (Reissue 2012), the Parties wish to permit their local government units to make the most efficient use of their powers by enabling them to cooperate with each other on a basis of mutual advantage and thereby to provide services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs and development of local communities;

NOW, THEREFORE, IT IS AGREED BY AND BETWEEN THE PARTIES, PURSUANT TO NEB. REV. STAT. § 13-807 (REISSUE 2012), AS FOLLOWS:

- I. This Agreement shall expire upon the completed performance of all the obligations of the parties as described herein.
- II. No separate legal or administrative entity will be created hereunder. Existing agents of the respective Parties will complete the terms of this Agreement.
- III. The purpose of this Agreement is to share the cost for a technical study of transit feasibility, hereinafter "The Project." Attached as exhibit "A" is a request for proposals for the Project, the description of which is incorporated herein by reference.
- IV. The Project will be financed as may be provided for by law by each of the respective Parties. With a total project cost not to exceed \$135,000, MAPA will contribute \$110,000, with \$100,000 from grant funds of the Nebraska Department of Roads (NDOR), \$8,000 from Federal funding sources, and \$2,000 from other MAPA funding sources. The County and area cities will contribute \$25,000 (the "Local Match"). This Agreement may be amended as may be required for purposes of aiding a party hereto in financing its obligations under this Agreement. County will enter into a separate interlocal agreement with the cities of Papillion, La Vista, Bellevue, Springfield and Gretna which will outline each entity's contribution amount towards the \$25,000 Local Match.
- V. Termination of this Agreement shall properly occur on the completion of the Project.
- VI. MAPA shall serve as the lead agent for the purposes of completion of the Project.
 MAPA, considering input from County and the cities involved in the Project, shall select a consultant for the Project described in Exhibit "A" and enter into-the appropriate contract with said consultant. Said Project and the contract for said Project shall be in

conformance with the terms of Exhibit "A". MAPA shall be responsible for payments due to said consultant under said contract, but shall be entitled to partial reimbursement of said payments as described in paragraph VII below.

- VII. County agrees to contribute a Local Match with a maximum of \$25,000 contribution towards the Project. However, should the proposed contract with the selected consultant cause the local match to exceed \$25,000, County may require MAPA to have the consultant revise the scope and cost of the contract to keep the local match at \$25,000 or less. County is not obligated to contribute more than\$25,000 without amendment of this Agreement. County agrees to submit the Local Match fund to MAPA as each participating city submits their proportionate share of the Local Match to County.
- VIII. Pursuant to Neb. Rev. Stat. § 13-804 (5) (Reissue 2007), the Parties hereto acknowledge, stipulate, and agree that this Agreement shall not relieve any public agency of any obligation or responsibility imposed upon it by law.
- IX. Pursuant to Neb. Rev. Stat. § 23-3113 (Reissue 2007), the Parties hereto declare and affirm that no officer, member, or employee, and no member of their governing bodies, and no other public official of parties who exercises any functions or responsibilities in the review or approval of the undertaking described in this Agreement or the performing of either Parties' obligations pursuant to this Agreement which affects his or her personal interest, or any partnership, or association in which he or she is directly or indirectly interested; nor shall any employee, nor any member of their governing bodies, have any interest, direct or indirect, in this Agreement or the proceeds thereof.
- X. It is understood and agreed by the Parties hereto that if any part, term, condition or provision of this Agreement is held to be illegal or in conflict with any law of this State or of the United State, the validity of the remaining parties, terms, conditions or provisions shall not be affected, and the rights and obligations of the Parties shall be construed and enforced as if the contract did not contain the particular part, term, condition or provisions held to be invalid.
- XI. The Parties agree to comply with the residency verification requirements of Neb. Rev. Stat. §4-108 through §4-114. The Parties are required and hereby agree to use a federal immigration verification system to determine the work eligibility status of new employees physically performing services within the State of Nebraska. A federal immigration verification system means the electronic verification of the work authorization program authorized by the Illegal Immigration Reform and immigrant Responsibility Act of 1996, 8 U.S.C. 1324a, known as the E-Verify Program, or an equivalent federal program designated by the United States Department of Homeland Security or other federal agency authorized to verify the work eligibility status of a newly hired employee.
