MAPA set to release new Traffic Reports for metro area in February

The Omaha-Council Bluffs Metropolitan Area Planning Agency (MAPA) prepares to release its bi-annual traffic reports for the metropolitan area.

Every two years, MAPA releases three reports: the Traffic Growth Report, the Top Intersections Report, and the Top Interchanges Report. The final reports and the Traffic Flow Map will be available in late February 2016.

MAPA completes these reports by compiling traffic count data from local governments, the Nebraska Department of Roads and the lowa Department of Transportation. The Top Intersections and Top Interchanges reports total the counts at locations throughout the metro to identify and rank the intersections moving the highest traffic volumes.

The Traffic Growth Report aims to provide a snapshot of the geographic distribution of Vehicle Miles Traveled (VMT) in the region. Additionally, this report compares the current figures to

previous versions of the report to identify trends within each area of the region.

The Traffic Growth Report estimates that total traffic growth was 1.8 percent from 2012 to 2014. Both Douglas and Sarpy County showed more than two percent growth during this period while Pottawattamie County experienced slightly more than one percent growth since 2012.


The Top Intersections Report shows the top intersection in the Omaha-Council Bluffs metropolitan area is once again 90th and Dodge Streets in Omaha with an estimated 89,500 vehicles per day. The intersections at 72nd and Dodge Streets and 120th and L Streets in Omaha were the

second and third highest intersections in the region as well. The intersection at 36th Street and Highway 370 was the top intersection in Sarpy County and the intersection at the South Expressway and the Interstate 80 and Interstate 29 ramps was the top intersection in Pottawattamie County.

The Top Interchanges report once again shows that the Interstate 80 and Interstate 680 interchange has the highest traffic volume of any interchange in the MAPA region. The interchange with the second highest traffic volume is at I-680 and West Dodge Road followed by I-80 and 60th Street as third highest.

MAPA makes recommendations to NDOR for next round of Build Nebraska Act priority projects

How best to invest \$600 million in Nebraska highway improvement projects under the next cycle of the Build Nebraska Act (LB 84) is being determined by the Nebraska Department of Roads (NDOR) after a series of regional public meetings in January. The next cycle will cover the second ten years, which begins in 2024.

The meetings focused on capital improvements such as projects which add new lanes or build new expressways or viaducts.

NDOR is updating and expanding its process for prioritizing projects to better consider economic impacts and include more input from stakeholders.

NDOR is scoring the projects being considered for the next cycle. Additional meetings will take place this spring to discuss specific projects. NDOR will announce the next round of Build Nebraska Act projects during the summer of 2016.

MAPA worked with local communities to submit a list of priority projects that are being studied as part of the Metro Area Travel Improvement Study that is being conducted with NDOR.

Build Nebraska Act Priority Projects

- Widen Highway 370 from I-80 to the Kennedy Freeway
- Reconstruct an interchange at US-6 (West Dodge Road) and 192nd Street
- Widen 72nd Street from I-80 to Hwy 370
- Widen Hwy 64 (Maple Road) from I-680 to 204th Street
- Widen US-275/Hwy 92 (West Center Road/ Industrial Road) from 132nd Street to US-6
- Bus Rapid Transit (BRT) construction on 24th Street for 2nd phase of project
- Construct an expressway on Platteview Road from US-75 to 84th St.
- Construct an interchange on I-80 at 180th Street

Plans for Omaha's Bus Rapid Transit (BRT) progress

Planning is on track for Nebraska's first Bus Rapid Transit (BRT) project. Dodge Street will be home to BRT starting the fall of 2018. BRT is a high-performance limited-stop transit service offering a fast, streamlined customer experience by deploying a variety of time-saving features.

Metro Transit is designing the project to look, feel and operate like a rail line using specialized transit buses with a unique brand and identity. The BRT will run every 10 minutes between Westroads Mall and downtown. It will serve as the spine of the transit system in Omaha and connect with nearly every Metro route. This corridor links major employment, residential and educational centers.

The BRT will include approximately 25 upscale rail-like stations with near-level boarding and priority treatment over other

vehicles. Station amenities include technology and signage displaying real-time arrival information and improved fare collection systems along with bicycle parking and landscaping. Construction of stations is expected to begin in 2017.

While the primary objective of the BRT is to improve mobility, it will also promote economic and infill development by fostering vibrant and livable communities with public spaces around stations and expand access to employment and educational opportunities.

In 2014, Metro was awarded a highly competitive \$15 million Federal Transportation Investment Generating Economic Recovery (TIGER) grant towards the BRT.

MAPA supported Metro's application for a TIGER grant actively through modeling work and formal correspondence with the Department of Transportation.

Since receiving the TIGER grant, the support of local partners such as MAPA, the City of Omaha, the Nebraska Department of Roads, the Federal Transit Administration, the philanthropic community and a dedicated stakeholder committee has assisted Metro in moving forward with this project.
