MAPA adds new housing program to list of available services for region

Add a new housing program to the list of the services MAPA offers. MAPA will now include owner-occupied rehabilitation among its programs and a new staff member is on board to implement it.

The program will focus more on rural and smaller communities but is available to assist more urban and suburban areas as well.

While housing programs are common areas of focus for economic development districts in Nebraska and Iowa, this is MAPA's first foray into housing. Addressing issues related to quality housing is a need that local communities have shared with MAPA staff.

Owner-occupied rehabilitation will include replacing key components of structures such as roofs, windows and heating and cooling systems, said Lynn Dittmer, Community and Economic Development Manager.



New MAPA housing program will focus on rehabilitation of owner-occupied homes in the five counties that MAPA represents.

Benefits of an owner-occupied rehabilitation work include: reduced monthly utility costs, improved energy performance, minimized ongoing maintenance for homeowners and preservation of housing units.

Preliminary plans are to secure funding from all available sources within the Nebraska Department of Economic Development to help repair eight houses per year, an anticipated expense of approximately \$200,000.



Chuck Karpf will manage MAPA's new housing program as the agency's Housing Coordinator. Karpf began working in development in the 1990s.

While the program will begin by assisting Nebraska homeowners, services will be available in the two Iowa counties MAPA represents: Pottawattamie and Mills.

Chuck Karpf will manage the housing program as MAPA's new Housing Coordinator. Karpf is the past Executive Director of both the Panhandle Area Development District in Scottsbluff and Panhandle Resource Conservation and Development Inc. He began working in rural development in the 1990s and also has 23 years of experience in the Nebraska banking industry.

"The nice thing about starting from scratch is the sky's the limit," said Karpf.

In the Panhandle, Karpf spearheaded a program that used local high school students to rehab and resell properties. This improved neighborhoods, property values, and developed future workforce.

Karpf will network with communities to assess their needs and assess the funding available. He will also be responsible for establishing the parameters of MAPA's owner-occupied housing rehabilitation program.

Omaha gets initial look at style of bus for Bus Rapid Transit (BRT) route at open houses

The public receives its first look at the potential style of bus which may be used on the Bus Rapid Transit (BRT) route. To help people visualize the appearance of a BRT bus, Metro Transit brought a 60-foot articulated bus to Omaha for two open houses on June 15. The open houses included project updates and discussion about the configuration of the buses.

Attendees toured the demo bus and were asked to provide feedback on amenities they would like to see inside the buses which will be used as part of the BRT project. Some of the amenities include next stop mapping, stop request buttons and different types of handrails as well as the types of bike storage available.

Little Steps Big Impact air quality program gets underway for 2016 with new ozone billboard

MAPA's Little Steps Big Impact ozone awareness and education program is underway just as the Omaha-Council Bluffs metropolitan region experiences higher concentrations of ground-level ozone.

Following the guidelines outlined in a memorandum of understanding, MAPA will issue news releases to the media and post messages on social media channels declaring Ozone Action Days when the Air Quality Index (AQI) forecasts are in the moderate range. The Douglas County Health Department will issue news releases for public health alerts if the AQI forecasts rise higher than the moderate range.

In addition to a media campaign with commercials on radio and TV stations, a digital billboard at 44th and Dodge Streets in Omaha will



provide updated information on the ground-level ozone forecast, alerting the public to current air quality conditions.

Efforts to build Western IA regional trail system taking shape

Work accomplished by the Pottawattamie County Trails Association will soon be visible to the public. Phase I of trail construction, from the Council Bluffs city limits to Hwy L-34 along Hwy 191, will start this summer. The multi-use trail will be 10 foot wide concrete.

The Association formed in 2012 to develop a countywide trail system. It is made up of volunteer residents and started with help from the National Park Service's Rivers, Trails, and Conservation Assistance Program with the support of the Pottawattamie County Conservation Board. Public planning meetings were held in 2012 throughout Pottawattamie County to determine preferred routes and types of trails. The outcomes of this process can be found at pottcountytrails.com. Through this process came the idea to expand the countywide trail to the surrounding areas to create a regional trail system - similar to the Central Iowa Trails system (www. centraliowatrails.com).

The Association drafted the name Frontier lowa Trails (FIT) and created a logo to be used to tie together a network of partnering trails. Partners could include neighboring county trails as well as neighboring states, Nebraska, Kansas and Missouri. As states partner together, they will be able to share the logo and include their state's name. For example, in Nebraska, it would be called "Frontier Nebraska Trails." The Association hopes to increase publicity and internet searches by having a uniform logo.

Currently, Frontier lowa Trails is forming a regional committee to bring together representatives from the area to discuss their



interest and vision for the development. The Association expects to reach out to the neighboring states later on this summer.
