# Heartland 2050 launches new initiative at August Summer Summit

Heartland 2050, MAPA's long-term regional visioning project, is focusing on a new initiative known as "Close the Gap." The initiative debuted at the Heartland 2050 Summer Summit in August. "Close the Gap" will focus on coordinating land use and transit to create a more walkable, livable region. It will emphasize projects which create a robust transportation network linking educational institutions and connecting areas of concentrated poverty to employment centers in the Omaha-Council Bluffs metropolitan area, benefiting the region's economy.

"Close the Gap" aims to fill the gaps which exist currently between vibrant neighborhoods by using transit to close the gap between those neighborhoods to create a more walkable region, said Greg Youell, MAPA Executive Director. Creating best practices for infill development, encouraging regulatory flexibility for development within neighborhoods, generating opportunities for public and private partnerships and identifying key corridors in the region are among the goals of the plan.

The Heartland 2050 Executive Committee prioritized improving transit in the region. "Close the Gap" links the goals of Heartland 2050 and the Action Plan compiled by the six Implementation Committees.

Creating a more walkable, livable region is at the heart of the message delivered by Jeff Speck, the keynote speaker for the Summer

Summit. Speck is a renowned city planner and author of "Walkable City: How Downtown can save America, One Step at a Time." Speck highlighted how making cities and communities more walkable improves their economic vibrancy and sustainability as well as the health of their residents.

Speck cited figures which show in 1970 Americans spent 10 percent of their income on transportation. In 2010, that number increased to 20 percent and is as high as 40 percent among low-income Americans. Speck said that percentage drops and allows people to retain a greater amount of their income when they live in communities which are more walkable and provide adequate access to transit. He outlined four elements which need to

be present to increase the number of people walking in the region. They include: development which provides venues and activities all within walking distance of each other and creates a reason to walk, infrastructure design which promotes a safe walk, a comfortable walk which provides a sense of enclosure and protection for pedestrians and places to walk which provide interesting streetscapes along the way.

Speck toured parts of the Omaha-Council Bluffs metropolitan area to view vibrant neighborhoods. During his presentation at the summit, he outlined recommendations on how to increase walkability in the region. One recommendation includes changing 12 foot wide lanes in Omaha to 10 feet in width and using the extra space to create bike lanes in targeted areas. This would require a change in state roads regulations. Speck says such a change helps improve safety for pedestrians, bicyclists and motorists. "A wider lane is a faster lane. A 12-foot lane is a highway lane according to The Institute of Transportation Engineers (ITE)," said Speck. Another recommendation: examining one-way streets to determine if some can be changed into two-way streets.

Speck also shared his message of walkability during a luncheon meeting with Omaha City Council members, Omaha Public Works Department staff and Douglas County Commissioners.

The purpose of the Leadership Certified Community Program is to provide a solid framework for communities to identify capacity, stimulate focused planning, and utilize technology to provide a strong foundation to meet the challenges of the future.

Being a Leadership Certified Community provides a distinct advantage when applying for Community Development Block Grants that are offered through the Nebraska Department of Economic Development. Those communities that are certified show the Nebraska Department of Economic Development a commitment to investment and continual community development. Currently, the City of Gretna is utilizing this advantage as it applies for a Downtown Revitalization grant through the Nebraska Department of Economic Development.

MAPA aided both these communities during the application process in partnership with Brook Aken, OPPD Economic Development Coordinator, and Lynn Kohout, Business Development Consultant with the Nebraska Department of Economic Development. With strong community-wide coordination the City of Gretna became a designated Nebraska

Department of Economic Development (NDED) Leadership Certified Community on May 17, 2016. The City of Ralston received its designation on August 16, 2016.

## MAPA partners with OHA on initial redevelopment discussions for Southside Terrace Homes



As part of the South Omaha Brownfields project, MAPA partnered with the Omaha Housing Authority (OHA) to assist in the redevelopment discussion at Southside Terrace Homes.

They are located from South 30th Street on the west to 28th Avenue on the east and from R Street on the north to W Street on the south.

Funding from the U.S. Environmental Protection Agency grant allowed MAPA to complete a Phase I assessment and create a conceptual redevelopment framework for the site.

Southside Terrace is 76 years old. The housing units are worn out and have become too costly to repair and maintain. OHA is looking at the next step of replacement and is exploring innovative redevelopment opportunities for this site, and how it can tie into the larger neighborhood and its existing resources.

Led by Benesch and HDR, input gathering interviews took place with key stakeholders on July 11th and 12th to gather thoughts on the following:

Aspirations, strengths, and

opportunities related to the site;

- Key issues and concerns about redevelopment options;
- Ideal types of land use, development, amenities, and other improvements;
- Community character, both existing and desired;
- Potential impacts of site redevelopment.

Input from these meetings was used for the basis of a design workshop on July 25th through July 27th.

The team produced conceptual plans for the study area. These plans consisted of recommendations relating to land use, building types and placement, street configurations, parking, open space, site amenities, and other features, and were developed with OHA, MAPA, and key stakeholders during a three-day interactive workshop.

The result is a conceptual redevelopment framework for the site that will act as a guide for the Master Developer of the site that OHA is hiring.

#### MAPA Board of Directors elects new chair

With the start of a new fiscal year, MAPA ushered in a new chair for its Board of Directors. Fellow board members nominated and elected Bellevue Mayor Rita Sanders to serve as Chair of MAPA's Board of Directors.

Mayor Sanders assumed her role as Chair at the July 28, 2016 board meeting. She succeeds Mills County Supervisor Ron Kohn who served as Board of Directors Chairman for 5 years. Supervisor Kohn was nominated and elected to serve as Board Vice-Chairman. He will continue in that role through the end of his term as a county supervisor in December 2016.

Prior to her election as board chair, Mayor Sanders served as Board Vice-Chair for 3 years. She is serving her second term as mayor of the City of Bellevue, Nebraska.

# Citizenship and Service award nominations due Sept. 2nd
