## D. Joint Project Delivery Efficiency Team

Mr. Jurgens, NDOR, and Ms. Maiefski, FHWA, presented the new Categorical Exclusion Programmatic Agreement. The goals include streamlining and increasing predictability of the NEPA process and insuring a thorough review of projects. The new PA is MAP-21 compliant.

The CE processing/approval authority is Level 1 – NDOR; Level 2 – NDOR; and Level 3 – FHWA.

Among questions asked of the presenters:

- Will Level 2 functional utility include raised median – Answer: Each project will be looked at individually.
- Concern there are different comments from state or federal reviews – Answer: More documents will be kept at NDOR so there will be fewer documents going through the state review process. This will be considered when the smart documents are built.
- Will these guidelines affect existing projects – Answer: Projects will most likely go through the new process and the new timeline of each project will be depend individually with each case.
- Is this process similar to other states – Answer: Iowa has a 5-step process which NDOR is not using but NDOR's new process does follow the national template.

## E. Funding Obligation and Project Status

Mr. Felschow presented to the Committee the funding obligation and project status. There is a balance of \$9,628,000 in STP and \$161,000 in TAP for Nebraska. There is still a significant need for some projects to be completed and several projects need to be programmed in the next several months. Because IDOT's reporting is on a quarterly basis, that information has not changed.

For the FY 2015 TIP summary, \$13 million is where the program started. After amendments and adjustments, there is an estimated \$5.5 million in projects programmed for FY 2015. There is an estimate of \$9.6 million in the FY 2015 OA balance. If the projects programmed for the year are completed as anticipated, there will be a remaining OA balance of over \$34 million.

#### F. Transportation Activities

Mr. Helgeson updated the Committee on various transportation activities --

- MTIS – Phase IB is nearly complete and Phase II is about to begin
- Little Steps Big Impact – Continuing education and 2-ride bus passes
- Platteview Road – The study continues
- EV Meeting – Several communities are interested in purchasing EV stations through grants and placing them around the area

#### G. Subcommittee Report

Citizens' Advisory Council (CAC)

- Public Participation process for the TIP and 2040 LRTP
- Bike-Ped Master Plan
- Brainstormed for vanpooling locations
- Providing ideas / feedback to improve 2050 LRTP public meetings

Coordinated Transit Committee (CTC)

- Awarded vehicles and operations funds using criteria the committee established
- Deciding direction for One Call One Click call center
- Brainstorming alternate forms of coordination based on the Coordinated Transit Plan goals, strategies and action steps

#### H. Additional Business

- Heartland 2050's Summit on July 15, 2015 as their lead kick-off for implementation
- 24<sup>th</sup> Street – the project is going to the 2<sup>nd</sup> level for approval and is expected to be approved for the full dollar amount
- The La Vista project is expected to be moved from illustrative to the fiscal constraint portion of TAP funding
- Tracy Troutner's last day with FHWA – Iowa is July 27<sup>th</sup> and he'll begin with IDOT on August 3.
