III. LB492 – Presented by Curt Simon (Information)

Mr. Simon presented to the committee an update on LB492 that would allow for the creation of a regional transit authority. Surrounding communities would be able to opt in to this via a vote of their governing body. The transit authority board would be comprised of 7 elected seats that would be filled during the general election.

IV. Choice Neighborhoods Grant - Presented by David Fanslau and Othello Meadows (Information)

Mr. Meadows and Mr. Fanslau presented to the committee an update on the Choice Neighborhoods Grant. This project was selected for a HUD grant of \$25M for redevelopment around North 30th Street in Omaha. This project has been led by the City of Omaha, 75 North, and the Omaha Housing Authority and will focus on a complete and connected neighborhood. The full amount of this grant in addition to \$157M must be spent by September 2025.

b. Heartland 2050 Ongoing Activities -

i. Mini Grant Program (N 24 Street) Update - Presented by Greg Youell

The mini-grant program utilizes set-aside transportation funds to fund Heartland 2050 projects in the MPO Region (\$250k in Nebraska and \$80k in Iowa). The next call for projects will be in December 2019. One goal for this project is to identify other revenue sources to allow the program to expand geographically. The 24th Street Corridor Study includes a series of projects aimed at improving the bike/ped environment. The mini-grant study will complete a housing market

assessment of current housing conditions and identify opportunities for infill development and transportation connections. The lead consultant for this project is Vireo.

ii. Nodes and Corridors Goals - Presented by Greg Youell Mr. Youell provided an update to the Committee on the Nodes and Corridors Goals of Heartland 2050 project including a review of the H2050 visioning process and identification of challenges and opportunities (people, places and resources). Mr. Gibbons recommended that Heartland 2050 and MAPA coordinate meetings with city planners in the region to discuss and examine and codes and zoning regulations. Ms. Quaites-Ferris recommended reviewing the North-South

corridor and identifying the next phase of the BRT. Mr. Youell stated that he would like for the committee to hear an update from Metro Transit on the Transit Development Plan (TDP) that includes some updates on the North-South corridor. Another recommendation from Mr. Jensen to hear an update on the TDP from Metro.

iii. Housing sub-committee - Presented by Zack Reinhardt

Mr. Reinhardt provided an updated on the Housing sub-committee ongoing activities:

- Work with The New BLK on the development of communication strategies and materials
- Re-development of the housing narrative and reframing housing issues from a data viewpoint to narrative/storytelling viewpoint. (Story of You, Story of Us & the Story of Now)
- Next steps: regulatory flexibility for missing middle housing, ex. ADU (Accessory Dwelling Units); focus on effective infill and affordability

Ms. Loewenstein provided a brief update on the Heartland 2050 Action Plan Refresh. Staff is working with The New BLK on this refresh.
