AGENDA ITEMS

A. Approval of the Minutes from the September 17, 2021 meeting

No questions, comments, or revisions were offered.

Kutilek moved to approve the minutes, Hinchey seconded the motion. Motion carried.

B. STBG Policy Guide for the FY2023 Transportation Improvement Program & Call for Projects

Barber presented changes to the policy guide and ProSeCom's recommendation. Williams asked for members of ProSeCom to explain their recommendation to not open a call for projects. Pfitzer and Miller responded, saying application time and federal program uncertainty both contributed to the decision. Barber and Helgerson expressed MAPA's desire to pursue a call for projects and that they felt it was the best way to set the program up for continued success.

Evans asked about re-scoring projects submitted last year. Helgerson responded that there may be some updates needed, but scores will remain essentially the same.

Evans moved to recommend approval of the policy guide and opening a call for projects to MAPA's Board of Directors, Wacker seconded the motion. Motion carried.

C. TAP Policy Guide for the FY2023 Transportation Improvement Program & Call for Projects

Barber presented the policy guide, stating that no changes were made this year, and said that TAP-C recommends approval of the guide and opening a call for projects. Williams asked about the order of magnitude of the potential funding increase. Helgerson responded that it is not entirely clear, but he expects funding to double.

Pfitzer moved to recommend approval of the policy guide and opening a call for projects to MAPA's Board of Directors, Suhr seconded the motion. Motion carried.

D. Central 24th Street Corridor Study

Jamie Winterstein and Kevin Carder from the City of Omaha presented on the process and findings of the study.

PMRNRD - Williams provided an update on the Western Douglas County trail.

NDOT District 2 - Hinchey & Gerbino-Bevins provided an update on District 2 construction.

Douglas - Kutilek provided an update on the county's 180th Street project.

Papillon - Evans provided an update on construction in Papillion.

Iowa DOT - Suhr updated the committee on projects in the district.

Omaha - Guy updated the committee on Omaha's signal system project. Pfitzer provided an update on other projects under construction and spoke about the general opposition to railroad crossing fees, saying he heard the issue is likely to be solved legislatively.

Sarpy - Wilson provided an update on construction in the county.

MAPA - Helgerson provided an update on MAPA's legislative committee and the availability of CRRSAA funds.




Overview

- Set annually evaluates next two years




Number of Fatalities




Fatality Rate (per 100M VMT)




Number of Serious Injuries
