A. Approval of the Minutes from the January 21, 2022 meeting

Wilson commented that he was present at the meeting, Suhr commented he was also present. Barber said he would correct the minutes to reflect this.

Pfitzer motioned to approve the minutes with the noted corrections, Suhr seconded the motion. Motion carried.

C. Regional Truck and Travel Time Performance Targets Progress Report (2018-2021)

Boerner presented the report.

D. FY2023 Transportation Improvement Program Progress

Barber presented on the status of the program's development.

E. Highway 75 Corridor & Freight Strategy Update

Barber presented on the progress of the study. Helgerson commented on previous studies that looked at construction of a new bridge and the challenges of dealing with environmental issues, specifically river flooding. Pfitzer commented on the core issue of needing freight movement, but residents not wanting it near them; he also expressed concerns about the flooding issues related to the bridge alternative. Morales noted that many of the freight trips are smaller single unit trucks rather than large long-haul vehicles. Cencic pointed out the importance of transit in the southern portion of the study area, especially that it would be included as part of the 24th Street BRT study.

F. Member Agency Updates

MAPA - Helgerson provided an update on CRRSAA funding & the upcoming MAPA Council of Officials event.

Metro Transit - Cencic gave an update on the MetroNEXT project, including considerations for regional transit and the scenarios being evaluated.

NDOT District 2 - Hinchey provided a District 2 construction update.

Papio-Misourri NRD - Williams gave an update on trail projects and the NEAT study.

Papillon - Evans provided a construction update.

Omaha PW - Pfitzer provided information on the streetcar project, noting that there will likely be monthly meetings starting soon; Wassenaar said she expects a significant increase in concrete prices soon.

Sarpy County - DeBerg provided a countywide construction update.

MAPA - Boerner let the committee know that a safety committee meeting and complete streets training event are both coming soon.

G. Additional Business

Suhr asked whether HDR has looked at flooding frequency as part of the Highway 75 Study, Helgerson responded they have not.

Pfitzer announced he is running for Douglas County engineer.

H. Adjournment
