3. Resolution 2023-02: Safe Streets and Roads for All Application - (ACTION)

The Board will consider for approval Resolution 2023-02; Safe Streets and Roads for All planning grant application. The application will request \$750,000 in federal funds for a Comprehensive Safety Action Plan to achieve significant decline in roadway fatalities and serious injuries on local roads with the goal of achieving zero by 2040.
