Iowa, in 1982, she would become the Pacific Junction City Clerk and be a lifeline for her community through the long recovery process following the catastrophic 2019 floods.

A Pacific Junction resident since 2001, Neppl worked as the part-time city clerk in Silver City, and served on the Pacific Junction City Council before becoming the City's clerk. But nothing could prepare her for the challenges of the devastation left by the floods.

"The greatest challenges have been staying strong and fighting for the town as a whole. I had made a promise to myself that I would not give up until I had helped every last person either get their buyout or the resources needed to stay," said Neppl. "The hardest thing was looking into the faces of the people, hearing their stories, and not being able to help enough."

She faced a large learning curve and long days to become familiar with federal and

state grant guidelines, tackle mountains of paperwork, and attend dozens of meetings-all the while working in another town because the floods destroyed city hall and trying to navigate the process as a flood survivor herself.

The human toll on fellow residents made her job a test of endurance and perseverance. "We've had several deaths of residents. Some never got to see their buyout or died right after receiving it," said Neppl. "Deaths are still taking place, and I truly believe the stress of the disaster really hurt people's health."

### MAPA presents its 2022 Annual Awards

MAPA recognized two individuals and one organization for their outstanding work in the region at its Council of Officials Annual Meeting on Oct. 5 in Glenwood, Iowa.



Korrena Neppl, City Clerk for Pacific Junction, Iowa, received MAPA's 2022 Regional Citizenship Award, Front Porch Investments received MAPA's 2022 Regional Service Award and David Brown, retired Greater Omaha Chamber President & CEO, received MAPA's Award of Merit.

The Award of Merit is MAPA's highest award for service. From 2003 until his retirement in 2022, Brown worked tirelessly to improve the quality of people's lives in the Greater Omaha region through economic development, understanding that improvements to the built environment are necessary to offer the lifestyle options the region's diverse workforce desires.

"Through his leadership, David has helped the MAPA region begin to focus on building vibrant places which attract people, and young talent in particular," said Michael Helgerson, MAPA Executive Director. "He's accomplished this through efforts such as the Urban Core Strategic Plan and his work to create a robust transportation network to increase mobility and connectivity."

The Regional Citizenship Award honors an individual who recognized regional problems and initiated and supported policies which required a shared regional effort and contributed to the region's quality of life.

As Pacific Junction City Clerk and a flood survivor herself, Korrena Neppl has been a selfless leader throughout the entire process of helping the community recover in the aftermath of the historic 2019 floods by assisting the City and residents in securing state and federal aid.

The Regional Service Award is given to groups that have contributed to the metropolitan area to help improve or grow it.

Created in 2021, Front Porch Investments has jump-started a regional conversation about the need for affordable housing and has built a fund to support housing development throughout the region.

#### MAPA entry wins NADO's photo contest



We have some exciting news to share! MAPA submitted a photo of the newly redeveloped Gene Leahy Mall for the National Association of Development Organizations' (NADO) photo contest and it won the "Building Vibrant Places" category.

In 2019, the City began a \$325 million riverfront transformational redevelopment project to include three parks. The Gene Leahy Mall is the first of these parks to open.

These efforts are part of the Urban Core Strategic Plan to bring partners on both sides of the Missouri River together to continue investment in the region's central business district.

MAPA awarded funding to reconfigure downtown streets around the park to have two-way traffic, enhance walkability, and support multimodal transportation connections.

# U.S. EDA awards Blair \$1.5 million for water infrastructure improvements

Business growth at the biocampus facility in Blair will receive a boost through a \$1.5 million grant from the U.S. Economic Development Administration (EDA).

The EDA awarded the City of Blair the grant to increase water capacity to the city's biocampus to support a more than \$300 million expansion.

The grant will be matched with \$2 million in local funds and is expected to create 115 jobs and generate \$345 million in private investment.

MAPA secured the \$1.5 million grant for the City of Blair and will administer the project. MAPA's Community Development planners are available to assist your community too. ### City of Omaha unveils Urban Ag Zoning Ordinance

A 2018 Community Needs Assessment determined approximately 12.4% of the Omaha-Council Bluffs metro population experiences food insecurity.

To increase the ability of residents to grow healthy foods and reduce food insecurity, the City of Omaha Planning Department, in coordination with Heartland 2050 Local Food Coordinating Council, has developed a Draft Urban Agriculture Guide which includes an Urban Agriculture Zoning Ordinance.

The Draft Urban Agriculture Guide includes four urban agriculture classifications. These classifications vary depending on the intensity of activity and underlying zoning district and have different permitting requirements.

The proposed Urban Agriculture Zoning Ordinance would allow permanent and temporary structures as well as on-site sales with a conditional use permit.

The Federal Emergency Management Agency's home buyout program compensates homeowners for their property loss but prevents them from rebuilding on that same land. For Neppl, it is a bittersweet experience.

"You hand them their check offering them the relief they deserve and wait for so long, knowing they are leaving and never coming back. Every person you helped get the buyout was, ultimately, another nail in the coffin towards killing your town," said Neppl.

For this determined city clerk, hobbies and vacations remain on hold while she works to get the few remaining residents their buyouts.

"I want my legacy to be that I was part of rebuilding Pacific Junction after the catastrophic floods of 2019 and that I always treated the flood victims with dignity, respect and kindness, and that my colleagues see my sometimes overbearing, 'say anything' personality as passion because I cared."

For her unwavering dedication to help her community, MAPA awarded Korrena Neppl its 2022 Regional Citizenship Award.
