#### **Action Items**

A. Approval of the Agenda

#### C. FY2023 Transportation Improvement Program (TIP) Amendment

Travis Halm presented the Nishnabotna Bend River Access Project, which was in the FY2022 TIP and needed to be imported into the FY2023 TIP. Halm added that the project was awarded funding last year through the National Rec Trails funding program.

Gettys motioned to approve the TIP Amendment. Motion was seconded by Struble. Motion approved unanimously.

#### D. FY2024 Call for Projects

Travis Halm announced that the FY2024 Call for Projects would be delayed until at least November. Halm noted that the delay was due to a hold put on TAP funding by the lowa DOT and that MAPA was waiting for additional instructions. Halm added that the group would meet in November to open the STBG call for projects.

#### E. Additional Business

Steven Struble noted that Missouri Valley was awarded funding through the City Bridge program to bring the Canal Street bridge over Willow Creek into the city near the US 30 Bypass project. He added that the project was the result of numerous bypass and UP conflicts and that it would be replaced north of its existing location.

Gettys motioned to adjourn the meeting at 11:14. Motion was seconded by Clark and approved unanimously.
