## AGENDA ITEMS

## A. Approval of the Minutes from the July 21, 2021 meeting

#### B. FTA Section 5310 Program Update & Call for Projects for the FY2023 Transportation Improvement Program

Barber provided an update on the status of the 5310 program and presented the plan for an upcoming call for projects. The committee discussed the merits of a call for projects and the availability of funding.

Barber said that in spite of the item being listed as a recommendation to MAPA's board of directors, staff determined that is not necessary and unless the committee has qualms, the call for projects will move forward without need for a vote.

#### C. Status of the Coordinated Transit Plan Update

Barber informed the committee that the CTP does not need to be completed in 2021 and that more information will come regarding the update in the January 2022 meeting.

## D. 2022 CTC Planning

Barber led a discussion of what the 2022 meeting schedule will be. The committee was mixed on whether to keep meeting quarterly or return to monthly meetings, but generally felt a balance could be reached.

E. Additional Business

Barber presented information on notices of funding opportunities per a request by FTA Region VII.

The committee had a brief discussion about ORBT service and Metro Transit's new fare application for smartphones.
