Rich McFall called the meeting to order at 10:02a.

Discussion Items

1. <u>Draft MAPA 2025 Civil Rights Policy</u>

Court Barber presented the draft policy and asked the committee for feedback, including completion of the committee demographic survey. Rich asked whether the CTC felt a committee recommendation was best, or if individual organizations should provide comments separately, feeling that if the CTC provided a recommendation the group should spend a meeting going through the document. Tammy said individual feedback would be best, Rich agreed. Court said a final determination whether to include it on the next agenda could be made by the chairs.

2. Mobility Resource Guide Update

Court Barber led the committee in a discussion of the existing guide and what updates need to be made. Rich said his primary issue with the guide is that it is difficult to find.

Rich brought up other private, smaller operators; Court said these could be problematic due to their longevity, but we could create an additional electronic list that could be easily updated as things change.

Cale asked whether a rider guide is provided; Court said MAPA links to Metro's Moby guide, but that we could provide more links to guides like this (Metro has others).

Action Items:

Look at ways to improve access to the guide



- Look into adding an electronic list of providers to expand on what is in the physical guide
- Add more how-to content to the guide webpage

3. Additional Business & Public Comment

Rich mentioned the revamp of TTAC calendar events. Court added that he will be doing the same with CTC events, removing the existing recurring event and sending individual invitations about a month ahead of each meeting.

Rich brought up the potential for updating the bylaws to enable fully virtual meetings.
