### MAPA awarded \$2 million TRIPS grant

In December 2024, the U.S. Department of Transportation (USDOT) awarded MAPA a \$2 million grant to implement a prioritization process project known as Transformative Regional Investment Prioritization System (TRIPS).

The program provides funding to develop and implement a publicly accessible, transparent prioritization process for the ranking and selection of projects for inclusion in short and long-range transportation plans.

The USDOT awarded a total of \$10 million through the program for this fiscal year, with MAPA receiving the maximum award amount of \$2 million.

This pilot program will bring a revolutionary decisionmaking model to Nebraska's largest transportation planning organizations, the Nebraska Department of Transportation and MAPA, and will enhance selection efficiency and ensure that projects align with community needs and values.

### MAPA releases Civil Rights Policy for public comment

We're taking public comments on our Draft 2024-2027 Civil Rights Policy. The public comment period runs December 12, 2024 to January 6, 2025.

The Civil Rights Policy details our agency's policies to ensure nondiscrimination in all of our programs and services, and to encourage participation for residents who have limited proficiency in English. It also outlines the procedures for submitting complaints and the steps which will be taken to address and resolve them.

### **Calls for Projects open until mid-January**

MAPA has two open calls for projects for Fiscal Year 2026 federal transportation funding programs.

One is for MAPA's Transportation Management Area (TMA), which covers Douglas, Sarpy and the urbanized portion of Pottawattamie County. Local units of government including cities, counties and public transit agencies can apply for this funding.

Projects selected will be part of the FY2026 Transportation Improvement Program (TIP) funding cycle.

### The TMA call for projects is open until January 17, 2025.

The types of funding available:

- Surface Transportation Block Grant (STBG) Iowa communities/agencies only
- Transportation Alternatives Program (TAP) Iowa & Nebraska communities/agencies
- Carbon Reduction Program (CRP) Iowa & Nebraska communities/agencies

Project applications for the FY2026 funding cycle must be submitted no later than **4:30 p.m. January 17, 2025**.



Regional Planning Affiliation-18 (RPA-18) is taking applications for Regional Transportation Alternatives (TA-Set Aside/TAP) funding.

Regional Planning Affiliation-18 covers Harrison, Shelby, and Mills Counties and the rural portion of Pottawattamie County. Local units of government including cities, counties and public transit agencies are eligible for this funding.

Applications for the RPA-18 Regional Transportation Alternatives funding are due by **January 24, 2025**.


### MAPA hosts Indianapolis planning agency for peer exchange

Thanks to this coordination, the co-chair of MAPA's


Coordinated Transit Committee, who is a paratransit user, was able to attend an off-site meeting of our Transportation Technical Advisory Committee.
